Proclaiming June as LGBTQ+ Pride Month

WHEREAS, On June 28, 1969 police raided the Stonewall Inn, a gay bar in New York, for operating at a time when homosexuality was a crime in nearly every state, sparking six days of protests known as the Stonewall Uprising, where the LGBTQ+ community stood their ground and planted the seeds for a national civil rights movement that changed our nation forever; and

WHEREAS, June is nationally recognized as a time to celebrate generations of LGBTQ+ pioneers who fought and sacrificed to live openly and authentically, reminding all of us that the work to ensure dignity, respect, equity, and protection remains an ongoing struggle; and

WHEREAS, In 2015, in the United Supreme Court ruling in Obergefell v. Hodges, prohibitions on same-sex marriage were declared unconstitutional, guaranteeing that the right of two persons to marry cannot be infringed upon regardless of sexuality or gender, thus affirming that equal protections were guaranteed in the United States Constitution; and

WHEREAS, Countless LGBTQ+ organizations and businesses in Orange County, including Shanti, Viet Rainbow of Orange County, LGBT Center OC, Alianza Translatinx, OC Pride, and Radiant Health, provide essential resources & services to the County of Orange's residents, empowering thousands of individuals to live healthy and safe lives; and

WHEREAS, The County of Orange is committed to providing a safe and supportive environment for the LGBTQ+ community in their ongoing struggle against injustice in county initiatives and practices, recognizing that poverty, homelessness, health, unemployment, hate crimes, and all forms of violence are disproportionately high in the LGBTQ+ community and even more-so for girls and women of color.

NOW, THEREFORE BE IT RESOLVED THAT THE ORANGE COUNTY BOARD OF SUPERVISORS proclaim June 2023 as LGBTQ+ Pride Month, commemorating the contributions, achievements, and history of LGBTQ+ Americans in the County of Orange and across the United States of America.
